### **RECOGNISED P&I CLUBS and INSURANCE COMPANIES**

P&I Clubs listed below are considered to have met the requirements of the Maritime Labour Convention, 2006 Standard A2.5, Standard A2.6 and Standard A4.2. This circular provides guidelines on the documentation that is to be submitted to a Flag State (SKANReg) in order to be recognised as an acceptable insurance provider and to satisfy the requirements of Financial Security for St Kitts & Nevis International Ship Registry Seamen.

These requirements are:

- 1) adequate documentation on the company's financial standing and hence solvency.
- 2) the rating that the insurance company and/or its reinsurers hold by an independent and internationally recognized rating agency.
- 3) adequate documentation on reinsurance coverage on claims met by the company for liability incurred under the Maritime Labour Convention, 2006.
- 4) Evidence of inclusion of required standards as stipulated within the Maritime Labour Convention, 2006 regulations.

P&I Clubs within the International Group of P+I Clubs (<http://www.igpandi.org>) are automatically considered acceptable.
