The basic requirements are:

- the rating that the insurance company and/or its reinsurers hold by an independent and internationally recognized rating agency.
- adequate documentation on reinsurance coverage on claims met by the company for liability incurred under relevant Conventions such as CLC, BLC, WRC and MLC.

P&I Clubs within the International Group of P+I Clubs (<http://www.igpandi.org>) are automatically considered acceptable.
